## CONDITIONAL USE PERMIT APPLICATION

In addition to this application, the applicant must submit a site plan that shall include details of all parking areas, driveways, landscaping, drainage, buildings, lighting, and fencing being proposed on the parcel indicated below. Furthermore, the applicant must also submit a letter of intent to the city which explains each of the following points:

- Whether or not this use will substantially increase traffic hazards and traffic congestion.
- Whether or not this use will substantially increase fire hazards.
- Whether or not this use will adversely affect the character of the surrounding neighborhoods.
- Whether or not this use will adversely affect the general welfare of the city.
- Whether or not this use will overtax public utilities or community facilities.
- Whether or not this use will be in conflict with the comprehensive plan.
- The design and location of all parking and loading areas on the parcel.
- The design and location of all trash collection areas on the parcel.
- The location, availability, and compatibility of all utilities that will be needed for the use.
- Any plans for screening and buffering on the parcel.
- The location and dimensions of any required open spaces or building setbacks on the parcel.
- The general compatibility of this use with other uses surrounding it.
